PRESIDENTS REPORT

The Swansmen enjoyed a very busy and **VERY** successful 2023 and once again provide many opportunities for our members to enjoy good fellowship and help raise some very valuable money for the Club at the same time.



The year commenced as normal with the Annual Planning Seminar in February followed by the Lounge Busy Bee. The first of the Swansmen monthly dinners kicked off in March as did the fundraising for 2023.

It was an exciting yet frustrating year on field, with the Men's Reserves and the Women's League sides reaching the finals and the Men's League side **OH** so close. Unfortunately, the Women's League side was beaten in the Elimination Final but the Men's Reserves made it all the way to the Grand Final and won the flag, great effort for such a young side. The Men's League team was unlucky not to make Finals finishing two games out of the top five, the narrow loses at the beginning of the season proving costly. The All-Abilities team again proved to be a team to be reckoned with making Finals again in just their second year.

We congratulate the whole football department and the Men's, Women's and All-Abilities teams on their outstanding seasons and the continuing effort to develop home grown players for the future. The Swansmen appreciate the support received from **Phil Smart** and the coaching staff, both male and female, and to the players for making themselves available to speak at our dinner meetings. We look forward to the 2024 season.

The monthly dinner meetings were successful with approximately 30 in attendance each month. We heard from coaches, players and a diverse range of entertaining guest speakers including League Coach Andrew Pruyn, Dr. Kevin Smythe (Catalina Aircraft history), Andrew Embley, Nic Naitanui and Luke Shuey (Mandoon Panel), Mike Richardson (Ball legend 2023), Glen Mortimer (Retravision History and Trotting), Dr. Bruce Mullan (Pig and Livestock Scientist) and comedy magician James Diamond.

The Auction was sponsored by Retravision this year, donating \$5,000 of electrical items, which, along with the old players lockers, \$19,700, helped in raising the huge amount of \$65,695.



We have had an exceptionally successful fundraising year. Over \$110,000 net was raised through:

- the Thursday Members Night, Chase the Ace, raffle and wheel \$12,500.
- AFL Grand Final/Cash Bonanza Raffle \$13,800 (thanks to Peter Snow for coordinating).
- Auction \$63,000 (thanks to the Committee, Ross Leipold and the Club staff and all the donors).
- Wine Wall \$6,000 (thanks to wine sub-committee)
- Home Game Winning Margins \$2,400 (thanks to George van der Meulen).
- Swansmen Lounge Home Game Bar \$5,400 (thanks to 'bar manager' Peter Bacon).
- Plus, our Membership Subs, Sponsor-A-Picket, monthly dinner meetings and fines.

This amount will be returned to the Club through the annual sponsorship of a Count-Me-In table; \$10k for the changeroom renovations, the Women's League Best Player Awards; the Men's League Leading Goal Kicking Award and the end of season donation to the Club of \$100,000. This has been earmarked for special projects in 2024.

The support of the Thursday Members' night has been outstanding on all fronts. To the members who support us every week, the ticket sellers Tim Outred, Peter Clements, the raffle prize shoppers, Andrew Holmes and Peter Hodyl, the lotto ticket donator Darryl Crotty and all other helpers, we have created something special.

We continue to work with and welcome our Judda Bee members and look forward to strengthening the networking opportunities and mutual benefits that may arise. We ask all members to support and consider all the Club and Auction sponsors when in the market for appropriate goods and services. A full list is included on the back page.

I would like to sincerely thank your Committee for their support and strong contribution this year and to all the Club staff for their assistance and catering. I also acknowledge the interaction and cooperation we have with the Board, Staff and the Past Players & Officials Association.

We welcome new members to the Swansmen group. 40 YEARS STRONG. It is a great way to support the Club and get to experience it from the inside. Good luck to everyone – especially the players, for season 2024.





NOTES TO THE FINANCIAL STATEMENTS

Note 1: Statement of Significant Accounting Policies

This financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements under the Associations Incorporation Act 2015 (WA). To comply with the new Act, a revised Constitution was lodged with the Department of Mines, Industry Regulation & Safety in June 2019.

The Committee has determined that the Association is not a reporting entity because there are no users dependent on general purpose financial statements. Under the Act, the Association is classified as Tier 1 for reporting purposes and does not require an annual review or audit unless requested.

Note 2: Current Liability

The Swansmen are committed to pay out the Chase the Ace Jackpot at some time in the future. The Swansmen have committed to contribute up to \$100,000 early in 2024 for Club upgrades and projects.
